## **What data do we collect?**

AISME and Confnow! collect the following data:

- Personal identification information (Name, email address, residence address)
- Institution for working or researching
- Information about intolerances or allergies, if any
- Publications and personal interest
- AISME conference proposals (abstracts, papers) and details about conference participation
- Administrative information for invoice documents (fiscal code)

## **How do we collect your data?**

Through Confnow! systems you provide AISME databases with most of the data we collect. We collect data and process data when you:

- Register to the platform as standard user / member

- Register online as a simple conference registered user
- Submit a paper proposal for a conference
- Submit further personal data (fiscal code, personal address) for invoice purposes
- Upload whatever document concerning a payment (Bank transfer)
- Voluntarily complete a customer survey or provide feedback via email

AISME/Confnow! may also receive your data indirectly from the following sources:

- Submissions by *other* papers or panels where you are registered as co-proponent, i.e. meaning your name and email are filled in.

### **How will we use your data?**

AISME/Confnow! collect your data so that we can:

- View, list and manage your submitted papers
- Email you with any needed feedback concerning the submission process as well as the acceptance process, if requested by the conference policies
- Email you with confirmation about your registration to the conference as participant
- Forward your email and amount to pay to an external payment system (e.g. Stripe, Paypal) for the only purpose of completing the payment itself
- Set your payments as confirmed on the platform
- Inform the conference staff with all useful information concerning organization of related events (visits, lunches, coffee breaks)
- Compile an invoice document for payments concerning membership or conference participation

If you agree and if requested by the conference policies, AISME will share your data with external companies so that they may offer you their services

- Google Analytics
- Confnow!

When AISME processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent operations.

### **How do we store your data?**

AISME securely stores your data through Confnow! support at Aruba hosting servers ([https://www.aruba.it/informativa\\_arubaspa.pdf](https://www.aruba.it/informativa_arubaspa.pdf)), and specifically in a single database.

Confnow! will keep your data for as long as AISME steering committee as well as conference organizing and scientific committees will ask to do so. At any rate this will be for no more than 15 years. Once this time period has expired, we will delete your data by erasing the database.

### **Marketing**

Confnow! would like to send you information about products and services that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Confnow! from contacting you for marketing purposes.

### **What are your data protection rights?**

AISME would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request AISME for copies of your personal data.

The right to rectification – You have the right to request that AISME correct any information you believe is inaccurate.

The right to erasure – You have the right to request that AISME/Confnow! erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that AISME restrict the processing of your personal data, under the condition that the hosted conference scientific committee agrees with it.

The right to object to processing – You have the right to object to AISME's processing of your personal data, under the condition that the hosted conference scientific committee agrees with it.

The right to data portability – You have the right to request that AISME transfer the data that we have collected to another organization, or directly to you, under the condition that the hosted conference scientific committee agrees with it.

### **Cookies**

- Google Analytics cookies might be used for the only purposes of tracking anonymously the browsing of our website.
